



LETTER TO SCHOLARSHIP HOLDERS:
CONDITIONS OF ACCEPTANCE OF SCHOLARSHIPS FOR ARTISTIC GODCHILDREN

For your kind attention:

As for the past years, again for the year 2020, the Maria Antonietta Berlusconi MAB association, represented by its President, Silvio Andrea Beretta, by the Artistic Director, Igal Perrye and by the General Manager, Gisella Zilembo, reaffirms its commitment of its artistic and didactic staff to work pro bono and to devolve their remuneration to the association in order to finance a scholarship that fully covers the expenses of:

- attendance fee to the Artistic Residences
- accommodation (for those entitled, according to what is indicated in this regard on the website www.premiomab.it).

Scholarship holders, called *artistic godchildren*, can therefore take advantage of a great education and artistic opportunity. This privilege corresponds to an equally important commitment to godparents, and to the other students of the Artistic Residences who are not scholarship recipients.

For this reason, we anticipate respect, commitment and perseverance in the courses of study, as well as complete availability to participate to ancillary organizational activities that will complete, upon convocation of the event management, the training course, with a broad spectrum on the artistic profession and its dynamics and will constitute moments of responsibility of *godchildren*.

Furthermore, the *artistic godchildren* will, for each session:

- a) prepare a written summary of the activities carried out, to document various work sessions and to support the entire study group, to be transmitted in electronic format to the secretary of MAB (to the address info@premiomab.it), indicating in object "report RA session no. ... artistic godchild name and surname) STRICTLY within and no later than 5 days from the end of the session.
- b) Report at the beginning of each theoretical lesson on the topics previously looked at, upon teachers' question,
- c) prepare a final thesis on an assigned topic, respecting times and methods communicated by teachers.

Their work will be constantly monitored by the organization, as a guarantee of the fact that everything proceeds in the best way possible and that all the efforts made by the MAB association (through the technical-artistic cast, the presidency, the artistic direction, the staff), the schools of origin and families is not to be wasted.

On the MAB award site, the name of the godfather or godmother of reference will be published shortly, under which the student will be directly responsible to.



Any unjustified absences that are not communicated, unjustified withdrawal from the course or inadequate conduct during the course of the teaching activities, lack of respect for facilities or people, delays or omissions in the performance of tasks, damage to facilities, to people and things, waste and inappropriate behaviour to the policy of the host structure, they will result in the immediate loss of the status of the scholarship holder and the obligation to fully settle the charges due for attendance (quantified in 800 euro), accommodation and meals, for those entitled to them (amount corresponds to 500 euro for those who are granted accommodation and 200 for those who only enjoy meals: lunch and dinner).

The grant of the scholarship requires the full acceptance of all conditions listed above (including specified penalties); printing and signing of this letter is required, to be returned to MAB with a complete registration in its entirety and signed by the scholarship holder over the age of 18 (or by parental authority, for minors), along with a copy of identity documents of those who sign it (consent to the processing of data and images will be given at registration).
